### Course Description

Private instruction for students in the following instruments: bassoon, clarinet, contrabass, cornet, electric bass, euphonium, flute, classical guitar, harp, harpsichord, horn, oboe, organ, percussion piano, saxophone, trombone, trumpet, tuba, viola, violin, violoncello, or voice. Seminar attendance may be required. May be repeated for credit in accordance with degree plan. Prerequisites: Successful placement by audition; concurrent enrollment in an assigned University ensemble and MUAP 1010 for all music majors and minors.

### Additional Course Information

The course consists of private instruction in an applied music instrument, in a one-hour long, individual weekly lesson and (where appropriate) a group studio class. Students must meet with instructor and pass the audition before registering this course. This course number may be repeated for credit. Students must be concurrently enrolled in MUAP 1010 and a university ensemble per the requirements of the catalog.

### Program Learning Outcomes

By the completion of the program, students will be able to:

- demonstrate advanced technical proficiency on the violin, a deep understanding of musical interpretation across a variety of styles, and the ability to deliver polished solo and ensemble performances.
- Students will also develop critical listening skills, effective practice techniques, and a comprehensive understanding of music theory and history to inform their artistic expression and career as professional musicians.
- Students will be prepared for diverse career paths in the music industry, equipped with knowledge of audition preparation, professional networking, and performance entrepreneurship. They will also demonstrate professionalism in rehearsal, performance, and business practices.
- Students will understand the importance of physical and mental health in sustaining a successful performance career, practicing techniques for injury prevention, stress management, and overall well-being.

## Student Learning Outcomes

*This course is the final capstone for BM Performance majors as well as the senior recital for BM All-level Certification. The recital will be recorded and live-streamed.*

*Students completing this course will:*

- *Perform a formal solo recital of 30-45 minutes of music for Junior recitals and 45-60 minutes for Senior recitals.*
- *Demonstrate technical and musical skills evidentiary of 3 years (Junior Recital) or 4 years (Senior Recital) of applied study.*
- *Compose a written program with details of the music performed, including composer's name, dates, and a description of each composition performed. A draft of the written program is due to the applied professor at the recital hearing (one month prior to the recital). See the attached example as a reference.*

### Individual Learning Outcomes

#### **Freshmen year (MUAP 1213 semesters 1 & 2):**

At the completion of the 2nd semester (the freshman year), students will be able to:

- Play Major & Minor scale, three octaves and arpeggios by using "Carl Flesch" figuring system.
- Perform music in all positions from and be able to execute shifts accurately
- At least one short show piece per semester.
- complete a sonata in semester 2
- Perform at least two movements from the select concerto
- Perform all repertoire assigned over the course of the two semesters
- Perform studio recital in 2nd semester

#### **Sophomore year (MUAP 1213 semesters 3 & 4):**

At the completion of the 2nd semester (the sophomore year), students will be able to:

- Play most of Major & Minor scales and arpeggios in 3 octaves
- Play in any position
- Demonstrate technical ability to play double stops
- Perform their repertoire with dramatically expressive interpretation, showing understanding of the music, era and performance practices associated therewith
- Perform an entire sonata
- Perform one standard concerto
- Perform one selected part from Bach sonata or partita
- Perform studio recital in each semester

#### **Junior year (MUAP 3213 semesters 1 & 2):**

At the completion of the 2nd semester (the freshman year), students will be able to:

- Play all Major & Minor scales, three octaves and arpeggios by using "Carl Flesch" figuring system.
- Perform music in all positions from and be able to execute shifts accurately
- Perform three movements of Bach Sonata or Partitas
- Perform a complete sonata each semester
- Perform at least two movements from the select concerto
- Perform all repertoire assigned over the course of the two semesters

- Prepared junior recital with approved repertoires
- Complete Junior Recital if the degree plan required

**Senior year (MUAP 3213 semesters 3 & 4):**

At the completion of the 2nd semester (the freshman year), students will be able to:

- Play all Major & Minor scales and arpeggios in 3 octaves
- Play in any position
- Play with consistency of tone throughout range and registers
- Demonstrate technical ability to play double stops
- Perform their repertoire with dramatically expressive interpretation, showing understanding of the music, era and performance practices associated therewith
- Perform an entire sonata
- Perform one standard concerto
- Perform one entire Bach sonata or partita
- Complete Senior Recital with required repertoires

Repertoire decisions will be made together by professor and student. Most music will be available either for printing from CD Sheet music – available at the TAMIU Library – or student will be provided with a copy from professor (including bowings etc.). Whenever music is not legally available and needs to be purchased, it will be the student’s responsibility to acquire said music. Students are expected to provide their accompanist with CLEAN copies of all semester repertoire as soon as repertoire is assigned.

## Grading Criteria

### Course Structure, Requirements and Expectations

Students will be graded in 5 areas: Lesson and Studio Class; Recital Attendance; Repertoire; Midterm Recital (Studio Recital) or Exam; and the Final Jury.

*Lesson and Studio Class: 30% of Final Grade – 10 Points per Lesson or Studio Class; 20 Points per*

*Studio Performance:*

Students must attend all scheduled Lessons and Studio Classes on time, prepared, warmed up and ready to

play. \* (Please see attendance and make-up policy)

- Private Lesson

Each student will receive one lesson of 50 minutes per week, for a total of 15 lessons during the Fall 2013 Semester. Lesson day and time will be arranged individually.

Preparation for the lesson will require technical practice and repertoire study **every day**. Lesson time is for learning *technique* and applying that technique to studies and other music. Students are expected to learn and memorize their music outside of the lesson. Lesson time will not be spent learning notes. Students who have not learned their music may be sent to a practice room, and/or receive a failing grade for the lesson.

In your daily practice, be sure to work technical exercises, not just your repertoire. 1 (one) hour a day is the minimum required amount of practice time, which can be broken up into smaller segments. (Practice time does not include time spent on research) Failure to practice daily will result in a lower grade. Students who wish to receive an A grade will practice and study a minimum of 3 hours a day.

• Studio Class

Studio Class will meet once a week, Monday from 1:30-2:20 PM, location TBA (Please check the note which posted outside of my office door). All Applied instrument students attend and perform their semester repertoire with the instructor of record for one another according to a weekly rotation schedule designated by the teacher. Non-majors may be exempted from this requirement at the discretion of the instructor. Students will be expected to participate in class discussions and development of technical exercises and should be prepared to play according to the assigned schedule, which will allow each student to play **4 times during the semester**. For each of these 4 studio class performances, students will perform a different selection in order to receive full credit.

Failure to play on the assigned day or to perform the assigned repertoire due to incomplete preparation will result in a failing grade for that Studio Class assignment.

Preparation and Participation in Studio Class will require daily practice as for the private lesson.

*\*Please be sure you schedule sufficient warm-up time before your lesson and studio class. Anyone arriving at the lesson un-warm will be penalized in their lesson grade that day. The same rule applies to Studio Class.*

*Recital Attendance: 10% of Final Grade – 10 points per recital report and/or program*

Because one of the course objectives is to learn a variety of repertoire, students are required to attend all student, faculty and professional concerts and recitals presented at TAMIU and/or by the Laredo Philharmonic Orchestra. I encourage you to also attend any and all such concerts at LCC, or other venues in town or out of town. (Students are encouraged to attend instrumental recitals and concerts toward the goal of becoming well-rounded human beings and musicians.)

In order to receive credit you will need to bring me a copy of the program from every required event **within one week of the concert**, as well as a 1-page review\* of the concert for at least 3 of these concerts. 1 page will suffice; spelling and grammar count. If you have trouble with the writing process, I encourage you to seek help at the TAMIU Writing Center. At least 3 programs and reviews must be submitted to receive credit for this part of the course.

*\*Report Guidelines are the same as for your Convocation requirement*

*Repertoire: 20% of Final Grade – 100 points per piece; 50 points each for program notes*

- Students are required to learn 6 pieces during the semester – these may include etudes, sonata / concerto movements. Learning of piece includes correct technical and musical accuracy, indicating that the piece is “concert ready.”
- Music will be assigned on an individual basis.
- Students are required to obtain their own scores of assigned music.
- All Bach movements assigned must be memorized. There will be a 10% grade penalty each week the assignment is late. The final week to fulfill the requirement is the penultimate week of classes.

*Mid-term recital: 10% of Final Grade – 100 Points*

Students will perform on the Mid-term recital (Studio Recital). Each student will prepare one of their assigned pieces for the recital, as chosen by the instructor.

Pieces must be performed from memory and polished.

During semesters in which no Mid-term Recital is given, students will perform 2 of their pieces in Studio Class or in their lesson as their Mid-term exam.

*Jury: 30% of Final Grade – 300 points*

A final jury will be performed for and evaluated by a panel of the Music faculty. All assigned repertoire

must performance ready for the Jury. Additionally any Bach solo must be memorized. The student will choose his or her first selection, and the faculty will choose one or more additional selections. **Failure to perform a final**

**Jury will result in an "F" grade.**

### Grading Criteria

Students will be evaluated on the basis of their independent progress and achievements. Lesson and Studio Class grades will reflect the level of preparation of the assigned material. The final grade will reflect the student's improvement, quality of performance in Studio Class and on recitals, consistent practice, attendance, preparation of assigned material, written assignments, and jury performance.

Grading criteria are listed below:

Lesson & Studio Class: 30%

Recital Attendance: 10%

Repertoire: 20%

Mid-term Recital: 10%

Jury Grade: 30%

A - The grade of "A" is reserved for students who do *excellent* work. The student has shown exemplary attendance and preparation for lessons and Studio Class, and the student exhibits improvement in technique and musicianship

weekly and throughout the semester. In weekly lessons repeated material from the prior lesson has been perfected musically and technically. He or she has exceeded the minimum performance requirements for Studio Class, is performance ready on all assigned repertoire and/or has exceeded the minimum repertoire requirements. The student performs an exemplary Jury that is reflective of the hard work they have done during the semester. In

addition the student has performed on one or more student recitals.

B - A "B" means *very good* work, and is a very good grade. Lessons are on-time and well-prepared, and the student

exhibits improvement in technique and musicianship throughout the semester. In weekly lessons repeated material from the prior lesson shows improvement. All assigned repertoire is learned, although perhaps one piece may not be performance ready. The minimum performance requirements for Studio Class have been met. Absences are nonexistent or minimal, and are excused. The student sings a solid Jury reflective of adequate effort and practice. The student has performed on at least one student recital.

C - A "C" reflects *marginal* work. Lessons are prepared with minimal effort, resulting in a majority of lesson time being spent on learning notes, and the student exhibits marginal improvement in technique and musicianship throughout the semester, and/or there are unexcused absences. In weekly lessons repeated material from prior lessons shows no improvement. One or two assigned repertoire pieces may not be completely learned, and/or the student has not met the minimum performance requirements in Studio Class. The student's Jury has a few technical or musical problems.

D - A "D" shows consistent *unsatisfactory* preparation for lessons and Studio Class, and/or more than two unexcused absences. Weekly lessons show no improvement in repeated material, and it is obvious that the student has not prepared for the lesson. More than two assigned pieces are not completed by semester's end. The student is well below the minimum performance requirements in Studio Class, and there is little improvement – if at all – in technique and musicianship over the semester. The student's Jury contains many technical and musical problems, reflecting lack of preparation.

F - Student has serious problems with attendance, and/or is consistently unprepared for lessons. The student has

probably offended the professor with his or her lack of self-discipline. The student's Jury reflects the complete lack of consistent work, or the student failed to appear for the Jury.

## ATTENDANCE AND MAKE UP POLICY

Texas A&M International University Attendance policies apply to all scheduled class meetings (Lessons and Studio Class), in addition to the following Studio Policies.

Tardiness:

• **Tardiness of 15 minutes or more will result in an unexcused absence.**

- Tardiness of less than 15 minutes will lower your Lesson or Studio grade by no less than 10%.

*Excused Absences:*

- Each student is allowed 2 **excused** absences per semester without detriment to their grade. An absence is considered excused if the student gives the instructor prior notice of the absence. 24 hours notice is preferred, but I will excuse an absence with no less than 1 hour's prior notice. Do not, however, wait until an hour before class to tell me. If you call me 1 minute after the hour, you will receive an unexcused absence.
- A third excused absence will be considered a full absence, and the student will receive no points for the lesson, but may make up the missed lessons by learning extra repertoire or attending extra concerts.
- If a student has 4 (or more) excused absences, he or she has missed an entire month of class. A failing grade will result unless the student withdraws from the course before the final day to drop. It is the student's responsibility to drop the course.

*Make up lessons:*

- **Make up lessons will not be given for student-cancelled lessons.**

If you know you have a conflict, or are sick and know you will be sick for your lesson, you may switch lesson times with another student for that week in lieu of receiving an excused absence. **The switch must be amenable to both, and confirmed by both students. This should be done no more than once a semester.**

*Unexcused Absences:*

Lessons missed without notification will be unexcused. *In addition to receiving a zero grade for the unexcused absence, each will lower the student's final grade by 5 percentage points (or half a letter grade.)* 3 or more unexcused absences will result in a failing grade for the course.

*Studio Class absences:*

Guidelines are the same as above, but only one excused absence will be granted per semester for performances. If you are granted an excused absence, you will be expected to sing on the next Studio. It is your responsibility for switching with someone else on the schedule as well as checking with the accompanist to see if they can accommodate the change.

## University/College Policies

Please see the University Policies below.

### COVID-19 Related Policies

If you have tested positive for COVID-19, please refer to the Student Handbook, Appendix A (Attendance Rule) for instructions.

### Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:

- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.
- Illness that is too severe or contagious for the student to attend class.
- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

### Classroom Behavior (applies to online or Face-to-Face Classes)

TAMIU encourages classroom discussion and academic debate as an essential intellectual activity. It is essential that students learn to express and defend their beliefs, but it is also essential that they learn to listen and respond respectfully to others whose beliefs they may not share. The University will always tolerate different, unorthodox, and unpopular points of view, but it will not tolerate condescending or insulting remarks. When students verbally abuse or ridicule and intimidate others whose views they do not agree with, they subvert the free exchange of ideas that should characterize a university classroom. If their actions are deemed by the professor to be disruptive, they will be subject to appropriate disciplinary action (please refer to Student Handbook Article 4).

### TAMIU Honor Code: Plagiarism and Cheating

As a TAMIU student, you are bound by the TAMIU Honor Code to conduct yourself ethically in all your activities as a TAMIU student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at <https://www.tamiu.edu/scce/studenthandbook.shtml> (<https://www.tamiu.edu/scce/studenthandbook.shtml/>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

**Plagiarism:** Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMIU has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to give freshmen and sophomore students a "zero" for the assignment and to allow them to revise the assignment up to a grade of "F" (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.
  - *Caution:* Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that "it was only a draft" will not be accepted.
  - *Caution:* Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.
- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a "zero" for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an "F" in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an "F" in the course be allowed to withdraw from the course with a "W".
  - *Caution:* Chat groups that start off as "study groups" can easily devolve into "cheating groups." Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.
- **Student Right of Appeal:** Faculty will notify students immediately via the student's TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member's charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member's e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

## Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

## AI Policies

Your instructor will provide you with their personal policy on the use of AI in the classroom setting and associated coursework.

## TAMIU E-Mail and SafeZone

Personal Announcements sent to students through TAMIU E-mail (tamiu.edu or dusty email) are the official means of communicating course and university business with students and faculty –not the U.S. Mail and no other e-mail addresses. Students and faculty must check their TAMIU e-mail accounts regularly, if not daily. ## Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit. Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

Under Title IX of the Education Amendments of 1972, harassment based on sex, including harassment because of pregnancy or related conditions, is prohibited. A pregnant/parenting student must be granted an absence for as long as the student's physician deems the absence medically necessary. It is a violation of Title IX to ask for documentation relative to the pregnant/parenting student's status beyond what would be required for other medical conditions. TAMIU advises a pregnant/parenting student to notify their professor once the student is aware that accommodations for such will be necessary. It is recommended that the student and professor develop a reasonable plan for the student's completion of missed coursework or assignments. The Office of Equal Opportunity and Diversity (Lorissa M. Cortez, [lorissam.cortez@tamiau.edu](mailto:lorissam.cortez@tamiau.edu)) can assist the student and professor in working out the reasonable accommodations. In the event that a student will need a leave of absence for a substantial period of time, TAMIU urges the student to consider a Leave of Absence (LOA) as outlined in the TAMIU Student Handbook. As part of our efforts to assist and encourage all students towards graduation, TAMIU provides LOA's for students, including pregnant/parenting students, in accordance with the Attendance Rule and the Student LOA Rule. ## Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;

2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.

## WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMIU faculty or TAMIU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

## Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.

## Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

## Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

## Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.
