#### Attendance Policy

## Assignments

**1. Participation and Attendance (100 pts)**

Attendance is required and class participation is expected. A **maximum of one (1) absence** will be allowed without consequence. **Additional absences or chronic tardiness** will jeopardize your final grade. Three or more absences may require repeating the course. When possible, any absences should be discussed with the instructor in advance. Students are responsible for all material and assignments covered on days they are absent.

Because of the experiential format of this course, you are responsible for critically reading and preparing for class. The success of this course depends on students’ abilities to respectfully engage in class discussions and activities. It is essential that students come to class prepared to discuss

readings and engage in critical reflection. **"Preparing for class" is operationally defined as arriving to class prepared to raise questions and make comments based on the reading for that week.** Active participation throughout the semester, evidenced by thoughtful questions, comments, and responses to questions in a respectful atmosphere of –give-and-take# demonstrate your accepted responsibility for your learning in this course.

Professionalism & participation will be graded on the following:

- Prompt attendance at all class meeting times
- Participation in class discussions and all in-class experiential activities
- Attentiveness when others are speaking
- Willingness to take risks in a professional manner
- Ability to **respectfully hear** others' viewpoints **even when one does not agree**
- Demonstration of personal characteristics consistent with program expectations and professional ethics.

## **2. Case Conceptualization Presentations (200pts)**

We will use a case study to prompt exploration of theory concepts and assist in application of counseling skills. The same case will be analyzed using different theoretical lenses. You will be assigned presentation of the case using a specific theory on the first day of class. **The case conceptualization and treatment plan must follow the specific format provided by the instructor.**

You will present your case conceptualization in class in a professional manner, using a power point format. You will be required to bring copies of your case conceptualization for the class. Your grade will be based on how effectively you conceptualize the case assigned. You will upload your case conceptualization to Blackboard on the day of your presentation.

## **3. Final Reflection (200 pts)**

You should write a reflection on your experience of all the theories covered throughout the semester. This activity will be used to help you understand your behavior, your values, attitudes, feelings, and life experiences as they relate to career choices and development. You should focus your reflections on your *favorite theory or theories, including a discussion on why these theories are appealing to you.* Reflections will need to be thoughtful and reference specific material that was covered in the reading. Critical reflection and thought on material and in class discussions is required. You should write no less than 3 pages double spaced using standard margins and Times New Roman font size 12. Papers must be written in first person and points will be lost for content, page length, grammar/punctuation, and APA style errors.

## **4. Exams (100 pts each)**

There will be 2 multiple choice exams during the term. Please be aware that **you are responsible for the material covered by the textbook even if it is not covered during lecture.** The Final Exam will be comprehensive and it will be a mixture of multiple-choice items and short answer questions. All exams will be taken online per University policy. You will be required to purchase the \$15 license for the software called *Respondus Lockdown + Monitor* in order to take the final exam. **Missed exams:** Students will be allowed to make up a missed exam only if they experience a serious emergency, where it was impossible to complete an exam as scheduled. Legitimate documentation (e.g., a doctor's note, a police report, a religious service program, a letter verifying a university sponsored event, etc.) must be provided within a week of the missed exam. You may not make up an exam without proper documentation. It is up to students to schedule make up exams at a time that is convenient for the professor. Makeup exams must be completed within two weeks of the absence.

## **5. Theory Research Paper and Presentation (100 pts presentation + 100 pts paper)**

For this presentation, you will do a literature review on a particular theory and present your findings to the class. For this project, you have to find at least **4 peer reviewed** articles that discuss a range of issues related to the theory selected, including application, challenges, and new directions. Your presentation should be cohesive and focused on the findings of your literature review.

For the paper, you should write no less than 5 pages double spaced using standard margins and Times New Roman font size 12. Papers must be written in third person and points will be lost for content, page length, grammar/punctuation, and APA style errors..

For the presentation, you should treat it as a professional presentation and have a power point slide show to document your findings. You will have 20-30 min for your presentation and you will be graded on your presentation skills, as well as the quality of the content you are presenting.

## **6. Research Team Participation (200 pts)**

Conducting research is an exciting process of discovery and learning. It provides many opportunities to develop a deep understanding about the scientific method and specific research topics. It also involves the student in a professional role that requires ethical responsibility. This class

requirement is designed so that you engage in the process of research and acquire the skills necessary to develop and manage all aspects of a research project under the mentorship of MACP faculty.

Every person is different in their learning and what they may accomplish. Research activity usually involves reading so that you can develop a foundation concerning the literature and issues that are confronted in the investigation. You may also assist in data collection and entry. There may be other things to do as well, and usually new activities arise, so the overall road-map for any semester is very flexible. I also expect students to be "self-starters" and able to work relatively independently. Each one of the faculty in the MACP program will hold meetings each week/biweekly (about 45 minutes) to talk about their research projects, interests, and expectations for participating in their research team. In these meetings faculty will also discuss issues, concerns, or ideas about their research agenda that are important to talk about.

### Grading Expectations

Note that these evaluative guidelines may be revised in accordance with the unique aspects of the project and upon agreement with student.

1. Successful completion of at least 3 assigned responsibilities listed below; if you need to add items to the list, feel free to do so with your faculty member's approval. The faculty member from the research team(s) you participate in will rate the quality of your involvement with the project using a research team participation evaluation rubric.
2. Preparation of a research report (2 pages minimum). This report must relate the activities you performed as a member of the research team to the content and experiences of this class.

### List of Potential Research Team Activities

- Develop and enhance critical-thinking skills
- Learn to use statistical software programs (e.g., SPSS, SAS)
- Participate in the data-collection process
- Develop the ability to conduct literature searches through the library and internet
- Develop a portfolio of research reports and summarizations
- Develop familiarity with various research methodologies and related concerns
- Develop capacity to pose effective research questions and hypotheses
- Develop understanding of statistical analyses and data management skills
- Further develop reading and comprehension of scientific articles
- Develop and improve technical writing and oral presentation skills, as well as research proposal writing
- Apply ethical principles in actual research situations
- Develop and pursue your unique research question(s)
- Preparation of research report for submission to professional meeting

### COVID-19 Related Policies

### Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:

- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.

- Illness that is too severe or contagious for the student to attend class.
- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

## Classroom Behavior (applies to online or Face-to-Face Classes)

TAMU encourages classroom discussion and academic debate as an essential intellectual activity. It is essential that students learn to express and defend their beliefs, but it is also essential that they learn to listen and respond respectfully to others whose beliefs they may not share. The University will always tolerate different, unorthodox, and unpopular points of view, but it will not tolerate condescending or insulting remarks. When students verbally abuse or ridicule and intimidate others whose views they do not agree with, they subvert the free exchange of ideas that should characterize a university classroom. If their actions are deemed by the professor to be disruptive, they will be subject to appropriate disciplinary action (please refer to Student Handbook Article 4).

## TAMU Honor Code: Plagiarism and Cheating

As a TAMU student, you are bound by the TAMU Honor Code to conduct yourself ethically in all your activities as a TAMU student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at <https://www.tamui.edu/scce/studenthandbook.shtml> (<https://www.tamui.edu/scce/studenthandbook.shtml>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

**Plagiarism:** Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMU has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to give freshmen and sophomore students a "zero" for the assignment and to allow them to revise the assignment up to a grade of "F" (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.

- **Caution:** Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that “it was only a draft” will not be accepted.
- **Caution:** Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.
- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a “zero” for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an “F” in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an “F” in the course be allowed to withdraw from the course with a “W.”
  - **Caution:** Chat groups that start off as “study groups” can easily devolve into “cheating groups.” Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.
- **Student Right of Appeal:** Faculty will notify students immediately via the student’s TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member’s charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member’s e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

## Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

## AI Policies

## TAMIU E-Mail and SafeZone

Personal Announcements sent to students through TAMIU E-mail (tamiu.edu or dusty email) are the official means of communicating course and university business with students and faculty –not the U.S. Mail and no other e-mail addresses. ## Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit. Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

## Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;
2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.

## WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMIU faculty or TAMIU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

## Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.





## Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

## Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

## Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.
