### Course Description

A seminar course on topics of current biological interest. May be repeated when topic changes. No laboratory section included. Prerequisites:

Graduate standing and permission of the instructor.

### Additional Course Information

The Atmospheric Chemistry course objective is to understand the methodology and application of chemistry in the understanding of the structure and composition of the atmosphere. The course will cover the strengths and limitations of varying techniques to model atmospheric oxidants and radicals. Ozone formation and reactivity will be covered. Air composition and pollution chemistry will be introduced along with their impacts on climate. Graduate students will have an additional individual research project.

#### Course Pre-requisite

Successful completion of General Chemistry and Organic Chemistry. Recommended Physics course completion.

### AI Use Policy

AI tools may be used as learning aids in this course, such as for clarifying concepts, improving writing, or generating data visualizations. However, all submitted work must reflect your own effort and understanding.

#### Permitted Uses:

- Assisting with editing, grammar, or formatting.
- Clarifying or explaining concepts for learning.

#### Prohibited Uses:

- Submitting AI-generated content as your own.
- Using AI to complete assessments meant to reflect independent effort.

If you use AI, you must disclose how it was used (e.g., “AI was used for grammar edits”). Misuse of AI, such as uncritical copying or misrepresentation of effort, will be treated as a violation of academic integrity, following university policy.

AI should support your learning—not replace it. Always verify AI-generated content and seek help if needed.

## Presentation Note Card & Slide Policy

In our seminar class, the goal is for you to **demonstrate mastery of your topic**—not just read from a script. This means I want to hear *your* understanding, in *your* words, and see you engage naturally with your audience.

To support this, here are our guidelines for presentations:

### 1. Note Cards

- You may bring up to **3–4 small note cards** (front side only) with you.
- These should have **short bullet points, key terms, or prompts**—not full sentences or a written script.
- Think of them as “memory joggers,” not something to read word-for-word.
- Any notecards used must be turned in to the instructor after your presentation.

### 2. PowerPoint Slides

- Slides should contain **concise bullet points, visuals, graphs, or keywords**—not full paragraphs or full sentences.
- Reading directly from your slides is **not** expected and will greatly decrease your presentation grade. Instead, use them as a visual guide while you expand on the ideas in your own words.

### 3. AI Use

- Your note cards and spoken presentation must be in your own words.
- Generative AI tools (e.g., ChatGPT, Bard) should **not** be used to create scripts or large portions of your spoken content. If you use AI for brainstorming or fact-checking, you must note that in your preparation materials.

### 4. Why This Matters

- Professional presentations rely on confident delivery and deep familiarity with the material, not on reading from prepared text.
- Learning to present without a script will help you develop skills that are valuable for graduate school, job interviews, and professional conferences.

**Tip:** Practice enough that your cards are only a backup—if you drop them, you can still keep going.

## Student Learning Outcomes

Upon completion of this course students will be able to:

- Demonstrate the ability to use various techniques to determine structure and characteristics of atmospheric compounds.
- Develop an understanding of the chemical processes in the atmosphere that are important to weather, climate, and the environment.
- Use chemistry techniques to predict molecular properties and chemical reactions.
- Recognize which approaches should be used in different chemical situations.
- Develop skills for presenting scientific findings through both oral presentations and written reports.
- Produce an effective paper on a scientific analysis of a chemical research project utilizing current atmospheric chemistry topics that will be formatted in a professional writing style specific to the sciences.

Students enrolled at the 5000 level will be further expected to:

- Graduate students will demonstrate the ability to review literature and formulate a review of scientific articles on atmospheric science.

## Assignments

As your instructor, I aim to help and encourage you to learn. All students learn differently; thus, I utilize various methods and assignments. This means you will have many different opportunities to apply the concepts we will investigate this semester. Correspondingly, there are many ways to earn points and demonstrate your understanding of the material in this course. WIN policy is to have 50% or more of the course grade from written assignments.

*Late assignments will be deducted 10% each day up to 3 days late. Assignments will not be accepted after 3 days late.*

To be graded on the grading scale defined above, you must complete all the following course requirements:

1. Pass the final exam.
2. Complete your class presentation.

### 3. Turn in your final paper (5000 level)

Failing to meet one or more of these requirements will result in a student not being graded by the grading scale described in the previous section. Grades in these cases are determined on an individual basis and are at the instructor's discretion. In general, you may expect at least a one-grade penalty for each requirement that is not fulfilled. Thus, failing the final, skipping an excessive number of homework assignments, or in-class assignments may result in a grade lower than the number of points you have accumulated would otherwise indicate.

If you feel that an error was made in the grading of homework or exams, you may request a regrade by notifying the instructor within **one week** of receiving it.

### Problem Sets/Quizzes/TopHat

Problem sets, quizzes, and Top Hat questions will be given over both concepts and the course material. The quizzes will consist of lecture information covered in the previous class, assigned videos, and assigned reading.

### Exams

This course consists of a Midterm and a Final Exam. Exams will cover the reading assignments, lectures, discussions, and exercises. All exams must be taken during the regularly scheduled class times and will be done using Respondus Lockdown Browser. There will **not** be any makeup exams. A missed exam will count as a zero (excluding a **well-documented** University excused absence). If classes are cancelled by the University on the day of a scheduled exam, then the test is automatically scheduled for the next class lecture period.

### Writing Assignments

*Writing Assignments (see blackboard for up-to-date due dates):* Students will have prompted writing assignments each week over the covered material. These will be timed and completed in class. You must be present in class in order to submit your writing assignments.

### Current Topic Assignments

Students will break into groups of 2-3 students and will give a 15-minute presentation to the class on a current topic in atmospheric chemistry. Each group will provide a class handout during this time on the material covered. All material presented in these presentations is fair game for the final exam. Current topic presentations are intended as an overview of the subject, with citations from the recent literature.

### Research Paper

Instructions will be provided in a separate document available on Blackboard. A draft of the paper will be due November 1st, and the final research/review paper will be due the last day of class (December 2nd) by 5 pm in a Blackboard dropbox.

### Notes for Success

It has been the Instructor's experience that the students who do the following in the indicated sequence generally obtain higher grades in the class.

1. Read the relevant chapter or assigned article before attending the class (even though it may not be well understood at that point).
2. Regularly attend (and participate in) the lectures to obtain a verbal presentation of the material with important points emphasized.
3. Review the lecture notes the night after covering them in class.
4. Doing the assigned problems, beginning them the day they are provided.

### Attendance Policy

Students with three or more un-excused absences will receive an "F" in the course. It is the student's responsibility to promptly notify the instructor if there is an absence from the lecture, laboratory sessions, or examinations. **NO MAKEUP EXAMINATIONS** are given whatsoever! All unexcused assignments and examinations will be given a grade of ZERO!

Class courtesy is also an important aspect of the course, and the use of cellular phones, unrelated discussions, and interruption of fellow students' questions is discouraged.

## University/College Policies

### COVID-19 Related Policies

### Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:

- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.
- Illness that is too severe or contagious for the student to attend class.
- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make

up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

## Classroom Behavior (applies to online or Face-to-Face Classes)

In the classroom, students are expected to listen attentively, participate respectfully, and adhere to established rules. Behavior that interferes with the class lecture may result in disciplinary action, ensuring a productive and respectful learning environment for everyone. Any disputes over academic matters should be addressed calmly and constructively, ideally during designated times such as office hours or after class. If a student does not agree with a decision, they can request a meeting with the instructor to discuss their concerns in more detail. ## TAMU Honor Code: Plagiarism and Cheating

As a TAMU student, you are bound by the TAMU Honor Code to conduct yourself ethically in all your activities as a TAMU student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at Student Handbook (<https://www.tamui.edu/handbook/index.shtml>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

**Plagiarism:** Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMU has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to give freshmen and sophomore students a "zero" for the assignment and to allow them to revise the assignment up to a grade of "F" (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.
  - *Caution:* Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that "it was only a draft" will not be accepted.
  - *Caution:* Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.

- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a “zero” for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an “F” in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an “F” in the course be allowed to withdraw from the course with a “W.”
  - *Caution:* Chat groups that start off as “study groups” can easily devolve into “cheating groups.” Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.
- **Student Right of Appeal:** Faculty will notify students immediately via the student’s TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member’s charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member’s e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

## Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

## AI Policies

## TAMIU E-Mail and SafeZone

## Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit. Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

## Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;
2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.

## WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMIU faculty or TAMIU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

## Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.

## Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

## Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

## Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.
