Course Description

A study of current biological literature and the discussion of research in progress. May be repeated when topic changes. Required of all biology majors in their junior or senior year.

Additional Course Information

This course is designed to explore and present research topics with an emphasis on molecular modeling through peer-reviewed journal articles. The object of this course is to teach students to critically read peer-reviewed scientific articles. Students will read review papers and primary literature articles. Each week, three students will present on a pre-approved topic. All students are responsible for participating in the discussions each week. Additionally, professional development topics will prepare students for careers or postbaccalaureate opportunities in the sciences.

Student Learning Outcomes

Upon completion of this course, students will:

1. **Critically Analyze Research Articles:** Identify and evaluate the structure, methodology, and significance of peer-reviewed journal articles in physical chemistry.
2. **Communicate Scientific Findings:** Deliver clear and engaging presentations on complex physical chemistry research topics. Respond effectively to questions and engage in scientific discussions during Q&A sessions.
3. **Explore Interdisciplinary Applications:** Understand the role of physical chemistry in interdisciplinary contexts, including its applications in biology, environmental science, and materials science.
4. **Utilize Research Tools:** Demonstrate proficiency in using scientific databases (e.g., SciFinder, PubMed) to locate and select relevant research articles. Apply basic computational chemistry tools and techniques to understand physical chemistry phenomena.
5. **Develop Professional Skills:** Write effective CVs, personal statements, and cover letters tailored to graduate school or workforce applications. Present research findings in formats suitable for conferences, posters, or professional settings.



6. **Engage with the Scientific Community:** Participate in and reflect on science-related events, such as seminars or workshops, to connect with current trends in science.
7. **Foster Teamwork and Peer Learning:** Provide constructive feedback on peer presentations and incorporate feedback into their own work to enhance scientific communication skills.
8. **Prepare for Graduate Studies and Careers:** Explore career paths in physical chemistry and related fields, including industry, academia, and government. Develop strategies for applying to graduate programs or securing internships in science-related field.

Participation:

Class attendance is mandatory. Students will evaluate their peer's presentations, due at the end of each class, for the daily participation grade. Unexcused absences will receive a zero, and tardiness will count against your participation score. You must be present for the entire presentation to evaluate your peers and receive credit for your participation/evaluations.

Assignments:

During weeks without student presentations, the class will have various assignments, such as literature searches, CV drafts, group assignments, and personal statements. Assignments will be due at the end of class.

Article Presentation:

Each student group will be given 30 minutes to present on an approved topic and 10 minutes for questions and discussion. Presentation dates will be chosen on the first day of class. The presentation will be 45% of the overall course grade, 25% from the instructor evaluation, 10% from the summary and topic, and 10% from the peer evaluation scores. Evaluation rubrics will be provided on Blackboard.

Science Event:

Students must attend two community or outreach science events in the semester. A summary of the event and a picture of you participating must be uploaded to Dropbox in Blackboard for credit, 10% of the overall course grade within one week of attending the event. Email the professor about the event you plan to attend to confirm whether it will count. Examples of events include science fair judging, community science demonstrations,



and attending science research presentations outside of those required by this class or another class. Additional format instructions are provided on Blackboard.

AI Use Policy

AI tools may be used as learning aids in this course, such as to clarify concepts, improve writing, or generate data visualizations. However, all submitted work must reflect your own effort and understanding.

Permitted Uses:

- Assisting with editing, grammar, or formatting.
- Clarifying or explaining concepts for your learning.

Prohibited Uses:

- Submitting AI-generated content as your own.
- Using AI to complete assessments meant to reflect independent effort.

If you use AI, you must disclose how it was used (e.g., "AI was used for grammar edits"). Misuse of AI, such as uncritical copying or misrepresentation of effort, will be treated as a violation of academic integrity, following university policy.

AI should support your learning—not replace it. Always verify AI-generated content and seek help if needed.

Presentation Note Card & Slide Policy

In our seminar class, the goal is for you to **demonstrate mastery of your topic**—not just read from a script. This means I want to hear *your* understanding, in *your* words, and see you engage naturally with your audience.

To support this, here are our guidelines for presentations:

1. Note Cards

- You may bring up to **3–4 small note cards** (front side only) with you.
- These should have **short bullet points, key terms, or prompts**—not full sentences or a written script.
- Think of them as "memory joggers," not something to read word-for-word.
- Any notecards used must be turned in to the instructor after your presentation.

2. PowerPoint Slides

- Slides should contain **concise bullet points, visuals, graphs, or keywords**—not full paragraphs or full sentences.
- Reading directly from your slides is **not** expected and will greatly decrease your presentation grade. Instead, use them as a visual guide while you expand on the ideas in your own words.

3. AI Use

- Your note cards and spoken presentation must be in your own words.
- Generative AI tools (e.g., ChatGPT, Bard) should **not** be used to create scripts or large portions of your spoken content. If you use AI for brainstorming or fact-checking, you must note that in your preparation materials.

4. Why This Matters

- Professional presentations rely on confident delivery and deep familiarity with the material, not on reading from prepared text.
- Learning to present without a script will help you develop skills that are valuable for graduate school, job interviews, and professional conferences.

Tip: Practice enough that your cards are only a backup—if you drop them, you can still keep going.

Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:

- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.
- Illness that is too severe or contagious for the student to attend class.
- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

Classroom Behavior (applies to online or Face-to-Face Classes)

In the classroom, students are expected to listen attentively, participate respectfully, and adhere to established rules. Behavior that interferes with the class lecture may result in disciplinary action, ensuring a productive and respectful learning environment for everyone. Any disputes over academic

matters should be addressed calmly and constructively, ideally during designated times such as office hours or after class. If a student does not agree with a decision, they can request a meeting with the instructor to discuss their concerns in more detail. Should further resolution be needed, the student may escalate the matter to the department head or use formal grievance procedures as outlined in the sections below. TAMUI Honor Code: Plagiarism and Cheating

As a TAMUI student, you are bound by the TAMUI Honor Code to conduct yourself ethically in all your activities as a TAMUI student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at Student Handbook (<https://www.tamui.edu/handbook/index.shtml>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

Plagiarism: Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMUI has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to give freshmen and sophomore students a "zero" for the assignment and to allow them to revise the assignment up to a grade of "F" (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.
 - *Caution:* Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that "it was only a draft" will not be accepted.
 - *Caution:* Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.
- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a "zero" for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an "F" in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an "F" in the course be allowed to withdraw from the course with a "W."
 - *Caution:* Chat groups that start off as "study groups" can easily devolve into "cheating groups." Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member

of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.

- **Student Right of Appeal:** Faculty will notify students immediately via the student's TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member's charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member's e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

AI Policies

Your instructor will provide you with their personal policy on the use of AI in the classroom setting and associated coursework.

TAMIU E-Mail and SafeZone

Personal Announcements sent to students through TAMIU E-mail (tamiu.edu or dusty email) are the official means of communicating course and university business with students and faculty –not the U.S. Mail and no other e-mail addresses. Students and faculty must check their TAMIU e-mail accounts regularly, if not daily. Not having seen an important TAMIU e-mail or message from a faculty member, chair, or dean is not accepted as an excuse for failure to take important action.

Students, faculty, and staff are encouraged to download the SafeZone app, which is a free mobile app for all University faculty, staff, and students. SafeZone allows you to: report safety concerns (24/7), get connected with mental health professionals, activate location sharing with authorities, and anonymously report incidents. Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit. Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;
2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.

WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMIU faculty or TAMIU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.

Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of



the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.
