## Course Description

This course focuses on the study of research design and methods to prepare students to be proficient in the evaluation and utilization of evidence based practice within the clinical practice setting. Students will critically examine reported research to determine the utilization of scientific knowledge in order to provide high quality nursing health care, initiate change, and improve patient outcomes. Implementation science will be examined. Prerequisites: MATH 1342, NURS 5322, and NURS 5344

## Additional Course Information

*The university uses the learning management system BlackBoard. This course is divided into seven (7) weekly modules. Each module contains the learning objectives for the week, assigned readings and videos, and instructions for weekly assignments that include a discussion forum, a written assignment, and statistical analysis exercises/assignments. The instructions will include the grading rubrics for each assignment. The first six (6) weekly module runs from 12:01 AM CT Monday to Sunday at 11:59 PM CT. The seventh and final module runs from 12:01 AM CT Monday to Friday at 11:59 PM CT.*

You must follow American Psychological Association (APA) guidelines for all written assignments, including in-text citations and references, on discussion boards, in writing assignments, and in the written portion of the statistical exercises, unless otherwise specified.

All references used for discussion boards and writing assignments should be current (within the past 5 years) and come from reputable professional sources that are unbiased and evidence-based, such as peer-reviewed journals. The required textbook for this course cannot be used as a reference for assignments. In this course, you are required to conduct and include outside research (resources other than your textbook) as a reference to support your writing. **A DOI link of the article is required in the reference list.**

Examples of unacceptable references include, but are not limited to:

- out-of-date materials (published over 5 years ago);
- posts from social networks (i.e., Facebook);



- blogs;
- research articles without citations;
- websites ending in .com,. org,. net etc.
- ChatGPT and other generative AI sources

## Discussion Forums

Discussion Forum Questions and drop boxes for this assignment can be found in the corresponding weekly module found in BlackBoard. The instructor will respond to student posts to the forum each week and will be in the forums reviewing all comments and making additional responses to students and asking questions to promote further discussion. The instructor will review and grade all posts by Wednesday (11:59pm CT) following the end of the week's discussion forum deadline, which is Sundays at 11:59pm CT).

### Discussion Forum Submission Instructions

For each discussion forum the student's initial post should be substantial and complete. A "substantial and complete" initial post is one that includes a synthesis of evidence from the literature and contains a real-world example. It is a post of at least **150 words** that includes two or more literature references, provided at the end of the post with APA citations. This initial post should be made by the Wednesday of the week (by 11:59pm CT).

In addition, the student is to respond to at least **two postings from others in the class (peers) on at least two separate** occasions with follow-up replies that are substantial and which promote further discussion by asking follow-up questions. A "substantial" follow-up post is at least **100 words**, which is more than a simple "I agree with you" reply. It should be thoughtful, reflect a rationale for the statement, and pose a question to promote ongoing discussion on the topic.

Please review the rubric on BlackBoard for further details on how discussion board grades will be calculated. If you have any questions about this rubric, please email them to your instructor. The faculty and the assigned academic coach will provide feedback on all assignments other than discussion forums.

### Course Policy On Use of Artificial Intelligence (AI)

In this course, the only Artificial Intelligence (AI) tool allowed for use is **Grammarly Basic**, as this is supported by TAMIU which can be found at: <https://www.tamtu.edu/distance/technology/grammarly.shtml>. Otherwise, students must complete and submit all academic and clinical coursework using their own independent work, analysis, and writing.

Allowed: Students may use AI for:

- Brainstorming: Idea generation, questions to consider, themes or angles to explore.
- Outlining: Structuring your own paper, presentation, or project (e.g., headings, subheadings, sequence of points).
- Planning tasks: Milestones, timeliness, checklists for your workflow

Not Allowed: Students may not use AI for:

- Writing or generating any portion of an assignment
- Paraphrasing or rewording content
- Summarizing articles or research
- Producing discussion board posts or responses
- Writing care plans, SOAP notes, or clinical documentation
- Creating PowerPoint slides or poster content
- Submitting AI-produced text (even if "heavily edited") as your own
- Producing reference pages

The use of automated reference or citation generators (e.g., Zotero, MyBib, Citation Machine) is not recommended and is highly discouraged/prohibited due to their tendency to produce incorrect citations. Citations are to be formatted according to the American Psychological Association manual, following the edition specified in the course syllabus.

Students are required to include direct and clearly accessible links to all sources referenced in their written assignments. This requirement encompasses a diverse range of materials, including but not limited to journal articles, peer-reviewed studies, credible websites, and professional reports. The links should be formatted to direct faculty and instructors straight to the source, enabling convenient citation verification. Students must



take the time to double-check their links to ensure they lead directly to the cited content, thereby enhancing the overall quality and trustworthiness of their work.

Failure to adhere to the above policy will result in the following consequences:

#### Point Deductions

- Any assignments with broken or non-functional links will incur point deductions, affecting the overall grade as determined by the lead faculty.

#### Exclusion of References

- References that cannot be verified due to missing or incorrect links, screenshots, or lack of URLs/DOIs will not be counted toward the assignment's reference requirements.

#### Reduced Academic Integrity

- Failure to properly format citations and provide verifiable sources may negatively affect the assessment of the student's work and their ability to demonstrate academic rigor.
- Repeated or serious violations of the policy will be referred to the TAMU Honor Code for formal review. This includes, but is not limited to, submission of unverifiable sources, falsified or fabricated references, persistent use of broken or misleading links, or failure to correct issues after written notice.
- Such referrals may result in institutional sanctions in accordance with university policy, including a formal warning, assignment failure, course failure, or additional disciplinary actions as determined by the committee. These measures are implemented to protect the integrity of academic work and uphold professional and ethical standards expected in nursing education.

### Course Communication and Response Time

#### Communication and Response Time Policy

Students must check their email account every 24 hours to ensure they can respond to any email communication from their course faculty within 24-48 hours of receiving it. Emails sent to the course faculty should be sent to the BB email address, and the faculty will respond within 24-48 business hours. If the faculty has not responded within 48 business hours, the student must call or resend the email to confirm that the original email was received. Students should read any email sent by the course faculty thoroughly to ensure they respond within the designated or requested time frame. This is considered a professional responsibility.

#### Feedback and Response Time to Assignments and Assessments

The faculty will grade assignments and return them within 7-14 business days. Formal paper assignments will be graded, and feedback will be provided to students within 7-14 days.

#### Formal Paper Policy

All scholarly papers are expected to be written using the APA Format 7th Edition. Please ensure that the final draft is the copy the student plans to submit. If the copy submitted to Blackboard is found to contain plagiarism, the excuse, "Blackboard's rough draft I accidentally submitted," will NOT be a valid reason. The student will receive a "zero" for the assignment. The matter will be forwarded to the University Honor Council, with possible sanction or dismissal.

#### Late Assignment Policy

Papers must be submitted by 11:59 pm on the due date. Late papers will not be accepted for grading and will receive a score of 0 (Zero) unless the course faculty grants permission in advance. It is the student's responsibility to request permission to submit a late paper as soon as they become aware they will be late. It is also the responsibility of the student to ensure that the faculty member has received the paper through Blackboard Turnitin receipts by the due date.

## Grading Criteria

### CSON Grading and Grade Rounding

1. All graduate level students enrolled in a nursing course must achieve a grade of B or higher in both theory and if applicable in the clinical components of a course in order to pass that course and progress in the program. (NURS 5321 does not have a clinical component)
2. To pass a graduate level nursing course and progress in the program, a nursing student must attain an overall course average of 80% or higher.
3. Rounding: All grade assignments and assessments (exams, quizzes, etc.) will be calculated to the hundredth (i.e. 2 decimal points). The final numeric course grade are calculated to two decimal places and rounded mathematically as follows: Less than 0.45: grade will be round down to next whole number (i.e. 89.44 would be rounded down to 89). For grades that are 0.45 or greater the grade will be round up to next whole number (i.e. 89.45 would be rounded up to 90). For more information on rounding refer the CSON Student Handbook
4. All students enrolled in a graduate level nursing coursework must maintain a GPA of 3.0 or above to progress and graduate from the MSN program in the CNHS. Students must pass both clinical and theory components of a course in order to pass that course. A graduate student in the CNHS may receive no more than two C's during the course of graduate study to stay in the program.

## University/College Policies

### COVID-19 Related Policies

### Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:

- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.
- Illness that is too severe or contagious for the student to attend class.



- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

## Classroom Behavior (applies to online or Face-to-Face Classes)

In the classroom, students are expected to listen attentively, participate respectfully, and adhere to established rules. Behavior that interferes with the class lecture may result in disciplinary action, ensuring a productive and respectful learning environment for everyone. ## TAMU Honor Code: Plagiarism and Cheating

As a TAMU student, you are bound by the TAMU Honor Code to conduct yourself ethically in all your activities as a TAMU student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at Student Handbook (<https://www.tamtu.edu/handbook/index.shtml>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

**Plagiarism:** Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMU has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to give freshmen and sophomore students a "zero" for the assignment and to allow them to revise the assignment up to a grade of "F" (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.
- **Caution:** Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that "it was only a draft" will not be accepted.



- **Caution:** Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.
- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a “zero” for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an “F” in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an “F” in the course be allowed to withdraw from the course with a “W.”
  - **Caution:** Chat groups that start off as “study groups” can easily devolve into “cheating groups.” Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.
- **Student Right of Appeal:** Faculty will notify students immediately via the student’s TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member’s charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member’s e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

## Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

## AI Policies

## TAMIU E-Mail and SafeZone

## Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit. Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

## Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;
2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.

## WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMIU faculty or TAMIU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission

from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

## Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.

## Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

## Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

## Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.

## Online Courses and On-Campus Meetings

Texas Administrative Code (TAC), Title 19, Part 1, Chapter 2, Subchapter J, Section 2.202 ([https://texreg.sos.state.tx.us/public/readtac\\$ext.TacPage?sl=R&app=9&p\\_dir=&p\\_rloc=&p\\_tloc=&p\\_ploc=&pg=1&p\\_tac=&ti=19&pt=1&ch=2&rl=202](https://texreg.sos.state.tx.us/public/readtac$ext.TacPage?sl=R&app=9&p_dir=&p_rloc=&p_tloc=&p_ploc=&pg=1&p_tac=&ti=19&pt=1&ch=2&rl=202)), defines distance education as the formal educational process that occurs when students and instructors are not in the same physical setting for the majority (more than 50%) of instruction. Distance education includes hybrid and 100% online courses and programs as defined by the Texas Higher Education Coordinating Board (THECB):

- **Hybrid Course** - A distance education course in which more than 50 percent but less than 100 percent of instructional activity takes place when the student(s) and instructor(s) are in separate physical locations.
- **100-Percent Online Course** - A distance education course in which 100 percent of instructional activity takes place when the student(s) and instructor(s) are in separate physical locations. **Requirements for on-campus or in-person orientation, testing, academic support services, internships/fieldwork, or other non-instructional activities do not exclude a course from this category.**

In this online course, be sure to confirm what in-person meetings may be required of you (if applicable).

## Course Structure

This course is divided into 7 modules that open every Monday at 12:01 AM CT and close Sunday at 11:59 PM CT. Each module contains text book and supplemental readings, videos, powerpoint presentations, and lecture notes. To help students meet the weekly learning objectives there are weekly discussion forums as well as written and statistical exercises to be completed. To be successful in a 7-week course it is important that the student does not fall behind and begins their readings and written/statistical assignments early in the week. **Remember the first discussion board response is due by Wednesday and all written assignments (including the final discussion forum posting) for the week must be completed and submitted by Sunday at 11:59 PM CT.** The only exception is module 7. If the student finds themselves falling behind for any reason promptly contact the faculty.

## Student-Instructor Communication Policy and Response Time

Students must check their email account every 24 hours to ensure that they are able to respond to any email communication from their course faculty within 24-48 hours of receiving the email. Emails sent to the course faculty should be emailed to the TAMIU email address and the faculty will respond within 24-48 business hours. If the faculty has not responded within 48 business hours, the student should resend the email to the faculty to ensure that the original email was received. Students should read any email sent by the course faculty and from the university thoroughly to ensure that they respond within the designated time frame. This is considered a professional responsibility. In addition check daily for any special announcements the faculty may post.

## Instructor Feedback

The instructor will review all discussion forum posts by Wednesday (11:59pm CT) and following the end of the week's discussion forum deadline, which is Sunday at 11:59 pm CT). Grading will take place weekly following the Sunday final submission. The instructor will review and grade all written assignments and provide feedback within one week following the due date on the assignment. The instructor will respond to emails within 48 hours. Feedback will be provided to students via blackboard. .

## Formal Paper Policy

It is expected that all scholarly papers will be written using APA Format 7th Edition. All papers must be scanned with Grammarly for language editing before submission. **All references must have a DOI link.** Please ensure that the final draft is the copy the student plans to submit. If the copy submitted into Blackboard is found to have plagiarism, the excuse of "it was my rough draft I accidentally submitted," will NOT be a valid reason. The student will receive a "zero" for the assignment and the matter will be forwarded to the University Honor Council and possible sanction or dismissal.
