Course Description

The purpose of this course is to examine Global Health problems and challenges within the context of current realities. Looking at health and health care as a basic human right, students will explore health related concepts and trends within a global context. Geopolitical, immigration, socioeconomic conditions, and environmental factors will be analyzed in relation to health and health care delivery. Students will examine multinational corporate activities, the social and health consequences of armed conflict and rapid development, and the ways in which cultural and religious practices and beliefs may influence an individual's health or potential for recovery. This course is interchangeable with NURS 3312. Prerequisites: ENGL 1302 and admissions to BSPH program

WIN-Designation

This course is designated as a writing-intensive (WIN) course. In this course, writing will not only be the subject of study, but it will also serve as a method of learning. Students will learn how communication in written, oral, and visual forms change according to purpose and genre. Brainstorming, drafting, revising, and peer-workshopping are integrated into the course curriculum and are the required components of this writing-intensive course. The final Research Paper is the designated assignment for WIN assessment.

Additional Course Information

Use of Generative Artificial Intelligence (AI)

Generative AI can be a useful tool for learning when used appropriately. In this course, you will have opportunities to develop your own skills and demonstrate your learning both with and without the use of AI. For this reason, the amount and type of AI assistance permitted will vary by assignment.

You will never be required to use generative AI to complete an assignment or activity in this course.



- AI-0: No Generative AI — Complete the assignment without using generative AI.
- AI-1: Planning and Brainstorming — You may use generative AI to help brainstorm ideas or plan your approach. The work you submit must be developed and written by you.
- AI-2: AI-Assisted Collaboration and Revision — You may use generative AI to help develop, revise, or refine your work within the guidelines provided for the assignment.

When you choose to use AI where it is permitted, you are still responsible for the work you submit. This includes checking the accuracy of AI-generated information, using appropriate evidence and citations, and ensuring that your final submission reflects your understanding of the course material.

Some assignments may require you to disclose how you used AI if you choose to use it. Follow the instructions provided with each assignment. Using AI beyond the level permitted for an assignment, or failing to disclose its use when required, may be considered a violation of course and University academic integrity expectations.

C01: Explore current geo-political-social-cultural-economic-international realities as a basis for understanding Global Health issues and their relationship to knowledge and practice.

C02: Evaluate the role(s) of individuals and a profession in improving the health status of the global “community”, areas of which are being challenged by rapid and/or development, environmental deterioration, uncontrolled migration, and increasing privatization of basic resources.

C03: Create a proposal for behavior change by applying critical decision-making, clinical judgment, problem-solving, and the research process in the development of an assessment and plan for aggregate-level intervention to reduce health disparities.

C04: Analyze variables of economic growth and/or migration, relatively open borders, and cross-national collaboration on the health status of diverse populations on both sides of selected international borders.

C05: Use a comprehensive explanatory model to demonstrate and evaluate the influence of societal factors on health care status as measured by standardized rates used in global health.

C06: Articulate an understanding of and personal commitment to the World Health Organization’s goal of Health for All in the context of increasing globalization and the growing gap between developed and developing nations.

C07: Demonstrate competency with written English expression using discipline-specific language and APA formatting by writing papers of increasing difficulty throughout the semester as part of this Writing Intensive Course.

Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:

- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.
- Illness that is too severe or contagious for the student to attend class.
- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

Classroom Behavior (applies to online or Face-to-Face Classes)

In the classroom, students are expected to listen attentively, participate respectfully, and adhere to established rules. Behavior that interferes with the class lecture may result in disciplinary action, ensuring a productive and respectful learning environment for everyone. Any disputes over academic matters should be addressed calmly and constructively, ideally during designated times such as office hours or after class. If a student does not agree with a decision, they can request a meeting with the instructor to discuss their concerns in more detail. Should further resolution be needed, the student may escalate the matter to the department head or use formal grievance procedures as outlined in the sections below. TAMU Honor Code: Plagiarism and Cheating

As a TAMU student, you are bound by the TAMU Honor Code to conduct yourself ethically in all your activities as a TAMU student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at Student Handbook (<https://www.tamtu.edu/handbook/index.shtml>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

Plagiarism: Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the



Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMIU has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to give freshmen and sophomore students a "zero" for the assignment and to allow them to revise the assignment up to a grade of "F" (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.
 - *Caution:* Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that "it was only a draft" will not be accepted.
 - *Caution:* Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.
- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a "zero" for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an "F" in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an "F" in the course be allowed to withdraw from the course with a "W."
 - *Caution:* Chat groups that start off as "study groups" can easily devolve into "cheating groups." Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.
- **Student Right of Appeal:** Faculty will notify students immediately via the student's TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member's charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member's e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

AI Policies

Your instructor will provide you with their personal policy on the use of AI in the classroom setting and associated coursework.

TAMIU E-Mail and SafeZone

Personal Announcements sent to students through TAMIU E-mail (tamiu.edu or dusty email) are the official means of communicating course and university business with students and faculty –not the U.S. Mail and no other e-mail addresses. Students and faculty must check their TAMIU e-mail accounts regularly, if not daily. Not having seen an important TAMIU e-mail or message from a faculty member, chair, or dean is not accepted as an excuse for failure to take important action.

Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit.

Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;

2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.

WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMU faculty or TAMU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.

Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.

Mental Health and Well-Being

Distance Education Courses

Online Courses and On-Campus Meetings

Texas Administrative Code (TAC), Title 19, Part 1, Chapter 2, Subchapter J, Section 2.202 ([https://texreg.sos.state.tx.us/public/readtac\\$ext.TacPage?sl=R&app=9&p_dir=&p_rloc=&p_tloc=&p_ploc=&pg=1&p_tac=&ti=19&pt=1&ch=2&rl=202](https://texreg.sos.state.tx.us/public/readtac$ext.TacPage?sl=R&app=9&p_dir=&p_rloc=&p_tloc=&p_ploc=&pg=1&p_tac=&ti=19&pt=1&ch=2&rl=202)), defines distance education as the formal educational process that occurs when students and instructors are not in the same physical setting for the majority (more than 50%) of instruction. Distance education includes hybrid and 100% online courses and programs as defined by the Texas Higher Education Coordinating Board (THECB):

- **Hybrid Course** - A distance education course in which more than 50 percent but less than 100 percent of instructional activity takes place when the student(s) and instructor(s) are in separate physical locations.
- **100-Percent Online Course** - A distance education course in which 100 percent of instructional activity takes place when the student(s) and instructor(s) are in separate physical locations. **Requirements for on-campus or in-person orientation, testing, academic support services, internships/fieldwork, or other non-instructional activities do not exclude a course from this category.**



Course Structure

Students should first begin becoming acquainted with the course by visiting “Start Here” on Blackboard and completing all tasks in that section. The course is organized into weekly modules that include assigned readings, recorded lectures, and other instructional materials. Throughout the semester, students will complete module quizzes, Scientific Writing Workshops, Project Development Assignments, and Current Global Health Issues activities. Individual project work will build toward a collaborative Country Health Assessment Executive Brief completed at the end of the course. All module materials can be accessed by visiting “Content” on Blackboard.

Student-Instructor Communication Policy and Response Time

Announcements/Course Messages/Emails

Announcements will be posted for general announcements, such as upcoming events, changes to due dates, and the start of each module. All messages must be through “Course Messages.” The instructor will not respond through Outlook email. The instructor will log into the course at least 4 days each week, and responses to inquiries can be expected within 24-48 hours of receipt by the instructor. Please make sure to use proper grammar and professional language.

Assignments and Assessments

Grades for your assignments will be posted within 7-10 days from the due date. **Late submissions will not be graded.** Feedback will be available on Blackboard Ultra Assignment Feedback. If you cannot see feedback for an assignment, please reach out.

Course Communication Guidelines (Netiquette)

There are course expectations concerning etiquette or how we should treat each other online. We must consider these values as we communicate with one another. Online communication is a very critical component of any online environment. There could be asynchronous communication (which means you are involved in a communication that IS NOT coordinated in time; such as a discussion forums, emails, blogs, wikis, etc.) or synchronous communication (which means you are involved in a communication that IS coordinated in time; such as a LIVE chat sessions, LIVE office hours, web-conferences, etc.) in an online environment.

By definition, *etiquette* is “the customary code of polite behavior in society or among members of a particular profession or group.” In cyberspace, *netiquette* is “acceptable way of communicating and behaving on the Internet.”

Regardless of the type of communication used, you should always keep in mind the following:

- Be respectful
- Be considerate of others
- Think through before responding
- Write clearly and concisely
- Respond in a timely manner
- Use short paragraphs
- Spell-check your responses

Avoid:

- CAPITAL LETTERS may be used to EMPHASIZE, but avoid typing in only capital letters as it may “sound” AS THOUGH YOU’RE SHOUTING!
- Rambling writing style; get to the point quickly
- Screens full of text

Grading Scale/Schema (after Grade Breakdown section)

In determining the final course grade, the following scale is used in percentage or point value.

- 90-100 = A (900-1000 points)
- 80-89 = B (800-899 points)
- 70-79 = C (700-799 points)
- 69-60 = D (600-699 points)
- Below 60 = F (<=599 points)

NOTE: An incomplete cannot be given if the student does not have a passing grade at the time the incomplete is given.

Rubrics

Rubrics for each assignment can be found on Blackboard under "Content" and by visiting the respective module page. Each rubric provides a breakdown of key features that will be assessed for each assignment. Students are highly encouraged to review the assignment's rubric before developing and submitting each assignment.

Late Work Policy

No late or make-up work will be allowed for missed deadlines without approved justification. Approved exceptions are limited to circumstances recognized by university policy, including documented medical illness or emergency, family emergency, military obligations or deployments, university-sponsored activities with prior notification, or approved accommodations through the appropriate university office.

Requests for extensions or make-up work must be submitted no later than the end of the module following the missed assignment or activity (for example, if an assignment is due in Module 3, the request must be submitted by the end of Module 4). Retroactive requests submitted after this window will not be approved.

Group Work Policy

The Country Health Assessment Executive Brief is a collaborative assignment. Each group will submit **one final version** of the Executive Brief by the posted deadline. The submission must include a single APA 7th edition title page listing the names of all contributing group members. Unless otherwise determined through the peer evaluation process or documented evidence of non-participation, all contributing group members will receive the same grade.

Although the final Executive Brief is a group product, each student is expected to make meaningful contributions throughout the semester by completing their assigned Project Development Assignments, participating in group discussions, reviewing and integrating group members' work, and assisting with the preparation of the final Executive Brief.

To be considered a contributing group member, a student must meet **at least three (3) of the following five criteria**, including **Criterion 1 or Criterion 2**.

1. **Content Contribution:** Contributed original written content or substantive revisions to the Executive Brief.
2. **Assigned Responsibilities:** Completed assigned project responsibilities and submitted materials by the group's internal deadlines.
3. **Communication:** Participated in group meetings or group communications during the project.
4. **Documented Contributions:** Contributions can be verified through shared documents, tracked changes, comments, version history, or other documentation.
5. **Responsiveness:** Responded to group communications within 48 hours during active project periods (or by the next business day for weekend or late-night messages).

Students who do not meet the minimum participation requirements should not expect to receive full credit for the group assignment.

Groups are strongly encouraged to use a shared collaboration platform (e.g., Microsoft Word Online or Microsoft Teams) that maintains version history and records individual contributions. These records may be requested if participation concerns arise.

Concerns regarding a group member's participation should be communicated to the instructor **as soon as possible**, and no later than **one week before the Executive Brief is due**. Waiting until after the assignment has been submitted may limit the instructor's ability to intervene.

Following submission of the Executive Brief, each student will complete a confidential peer evaluation documenting the contributions of each group member. Peer evaluations, together with any supporting documentation, may be considered when determining individual grades on the group assignment.

Course Evaluation

At the end of this course, students are encouraged to complete a course evaluation that will be distributed to them via email and through a course link.

Turnitin Policy Or Other Types of Assignments in Other Systems

Students agree that by taking this course, all required papers, exams, class projects, or other assignments submitted for credit may be submitted to Turnitin.com or similar third parties to review and evaluate for originality and intellectual integrity. A description of the services, terms, and conditions of use, and privacy policy of turnitin.com is available on its website: <<http://www.turnitin.com/>>. Students understand that all work submitted to turnitin.com will be added to its database of papers. Students further understand that if the results of such a review support an allegation of academic dishonesty, the coursework in question, as well as any supporting materials, may be submitted to the Honor Council for investigation and further action.

Use of Work in Two or More Courses

Students may not submit work completed for one course to earn credit in another course unless they have received **explicit permission** from the instructor of the second course. In general, a single work product should only receive credit once. Submitting work from a previous course without permission will result in a grade of **0%** for that assignment.

Proctoring

No proctored assignments or assessments are required for this course.

Webcam Checkout for Personal Computer

If students are unable to use personal or borrowed computers and equipment, students may stop by the Instructional Technology and Distance Education Services office to check out webcams (with built-in microphones).
