Course Description

This course provides current clinical understanding of the etiology, research, and pharmacological treatments available for human psychological disorders. The course involves discussion and critical evaluation of current, historical, and interdisciplinary perspective to psychopathology and the pharmacological treatment options available. Prerequisite: PSYC 5307 or permission of the instructor.

Upon successful completion of this course, students will be able to:

1. Use professional vocabulary appropriate to the level of knowledge in clinical neuroscience and psychopharmacology in a counselor role.
 2. Describe the micro- and macro-anatomy of the CNS and the basic mechanisms of neurotransmission.
 3. Articulate the relationships between CNS anatomy, neurotransmission, and the key actions of psychopharmacology.
 4. Explain the relationship between neurological homeostasis and the maintenance of biopsychosocial wellbeing.
 5. Apply the fundamentals of pharmacokinetics and pharmacodynamics in the use of psychopharmaceuticals.
 6. Identify possible adverse reactions and drug interactions in managing the treatment of clients with mental disorders.
 7. Recognize cultural bias in the diagnosis of psychopathology and understands the importance of using this awareness to engage in culturally competent practices

AI Policy

This policy promotes the ethical and responsible use of AI technology.

As an MACP student, you are expected to submit original work, as demonstrated by full engagement with all requirements of any writing assignment (e.g., generating your ideas, finding and selecting research articles, synthesizing ideas, developing paper outlines, and finally presenting these in a written format to your instructor or your peers).

Writing

The MACP faculty recognizes that AI tools (e.g., Grammarly and Microsoft) can improve your original writing through the automated editing and proofing process. Unless otherwise specified, this editing and proofing process is permitted. It's also important to note that while these tools offer a few short-term benefits, the misuse and overuse of this technology will negatively impact your growth as a student and burgeoning scholar and clinician. In an effort to build your long-term writing skills, we strongly encourage you to use the TAMIU Writing Center. There, you will build your understanding of writing practices that AI tools cannot teach. Besides reading high-quality writing, having peers edit your work is probably one of the most important things that you can do to improve your writing skills. Additionally, you should be aware that you may be expected at any point in the program to demonstrate your writing abilities without the use of or assistance of technology.

Generating and synthesizing ideas

Similarly, using AI tools such as ChatGPT is permissible for refining ideas; however, as stated above, all writing generated from these ideas must be original to you and reflect your effort and understanding of the topic. Further, you remain responsible for fact-checking accuracy and substantiating all information you submit. It is unacceptable to cite a source you have not read and reviewed, and you can still be charged with plagiarism if sources are not appropriately credited.

Clinical practice

Be aware that AI tools that are not HIPAA-protected should never be used to assist with client-related tasks (e.g., note-writing, treatment planning). Submitting protected health information on these platforms constitutes a breach in ethical and legal practice.

Summary

Transparent proper use of AI tools is essential to ensure that your work reflects your academic and clinical skills. The consequences of policy nonadherence may include failing the assignment, failing the course, referral to the Honor Council, and removal from the program.

Participation & Attendance.

There can be no substitute for attendance in this class. **Come to class having read the text assignment and prepared to discuss the readings and case study assigned.** You will be evaluated on your participation in the discussions of the information and readings assigned. As an instructor, I am aware of students' preparedness for class, as it is evident in their contributions during discussions. Therefore, consistent unpreparedness will significantly impact your grade on the class.

Psychopharmacology Topic Presentation and Paper

These assignments will be completed individually. I prefer that the topics don't overlap, so we will discuss your preferences and options in class. You may upload your topic to its designated dropbox on Blackboard.

Paper



Choose a type of psychopharmaceutical drug that interests you related to mental illness (e.g. traditional antipsychotics, selective serotonin reuptake inhibitors, stimulants, methadone as a treatment for opioid addiction; psychopharmacological treatments for PTSD– these are only some examples, there are several available types of drugs). The purpose of the project is for you to gain more knowledge about a particular psychopharmacological drug that you can use in your current or future work in counseling. You will be responsible for writing a 4-5 page, APA style, research-based paper and you may include the following sections:

- A general clinical description of the class of drugs;
 - A history of the discovery and development of the class of drugs;
 - Provide examples of the various representatives of the class of drugs;
 - Hypothesized pharmacodynamics and pharmacokinetics of the drug class;
 - Select a single representative drug from the drug class;
 - Describe the expected treatment outcomes from use of this drug;
 - Anticipated adverse and side effects from use of this drug; and
 - A prognosis expected for use of this drug.

You must be able to present an accurate clinical picture of the drug, together with any ethical concerns related to the use of this drug that might arise in the counseling process, and a thorough review of appropriate responses to any hypothetical ethical concerns. This will assure a top quality paper, which will benefit you significantly in this course, and in your professional life.

Presentation

You will also be responsible for conducting a presentation about the psychopharmacological drug you chose. The presentation should summarize the same points outlined above for your paper. An alternative to doing a lecture style presentation is to engage the class in a panel discussion with the group members as experts, discussing your psychoactive drug and the relevance to counseling. A summary of the project and references should be given to the professor and distributed to the rest of the class. Both the presentation format and panel discussion format should be approximately 20-30 min in length.

Exams

There will be 3 exams during the semester and one final exam. Please be aware that ***you are responsible for the material covered by the textbooks even if it is not covered during lecture.*** The Final Exam will be comprehensive and it will be a mixture of multiple choice items and short answer questions.

Missed exams: Students will be allowed to make up a missed exam only if they experience a serious emergency, where it was impossible to complete an exam as scheduled. Legitimate documentation (e.g., a doctor's note, a police report, a religious service program, a letter verifying a university sponsored event, etc.) must be provided within a week of the missed exam. You may not make up an exam without proper documentation. It is up to students to schedule make up exams at a time that is convenient for the professor. Makeup exams must be completed within two weeks of the absence.

COVID-19 Related Policies

Required Class Attendance

Students are expected to attend every class in person (or virtually, if the class is online) and to complete all assignments. If you cannot attend class, it is your responsibility to communicate absences with your professors. The faculty member will decide if your excuse is valid and thus may provide lecture materials of the class. According to University policy, acceptable reasons for an absence, which cannot affect a student's grade, include:



- Participation in an authorized University activity.
- Death or major illness in a student's immediate family.
- Illness of a dependent family member.
- Participation in legal proceedings or administrative procedures that require a student's presence.
- Religious holy day.
- Illness that is too severe or contagious for the student to attend class.
- Required participation in military duties.
- Mandatory admission interviews for professional or graduate school which cannot be rescheduled.

Students are responsible for providing satisfactory evidence to faculty members within seven calendar days of their absence and return to class. They must substantiate the reason for the absence. If the absence is excused, faculty members must either provide students with the opportunity to make up the exam or other work missed, or provide a satisfactory alternative to complete the exam or other work missed within 30 calendar days from the date of absence. Students who miss class due to a University-sponsored activity are responsible for identifying their absences to their instructors with as much advance notice as possible.

Classroom Behavior (applies to online or Face-to-Face Classes)

In the classroom, students are expected to listen attentively, participate respectfully, and adhere to established rules. Behavior that interferes with the class lecture may result in disciplinary action, ensuring a productive and respectful learning environment for everyone. Any disputes over academic matters should be addressed calmly and constructively, ideally during designated times such as office hours or after class. If a student does not agree with a decision, they can request a meeting with the instructor to discuss their concerns in more detail. Should further resolution be needed, the student may escalate the matter to the department head or use formal grievance procedures as outlined in the sections below. TAMUI Honor Code: Plagiarism and Cheating

As a TAMUI student, you are bound by the TAMUI Honor Code to conduct yourself ethically in all your activities as a TAMUI student and to report violations of the Honor Code. Please read carefully the Student Handbook Article 7 and Article 10 available at Student Handbook (<https://www.tamui.edu/handbook/index.shtml>).

We are committed to strict enforcement of the Honor Code. Violations of the Honor Code tend to involve claiming work that is not one's own, most commonly plagiarism in written assignments and any form of cheating on exams and other types of assignments.

Plagiarism is the presentation of someone else's work as your own. It occurs when you:

1. Borrow someone else's facts, ideas, or opinions and put them entirely in your own words. You must acknowledge that these thoughts are not your own by immediately citing the source in your paper. Failure to do this is plagiarism.
2. Borrow someone else's words (short phrases, clauses, or sentences), you must enclose the copied words in quotation marks as well as citing the source. Failure to do this is plagiarism.
3. Present someone else's paper or exam (stolen, borrowed, or bought) as your own. You have committed a clearly intentional form of intellectual theft and have put your academic future in jeopardy. This is the worst form of plagiarism.

Here is another explanation from the 2020, seventh edition of the Manual of The American Psychological Association (APA):

"Plagiarism is the act of presenting the words, idea, or images of another as your own; it denies authors or creators of content the credit they are due. Whether deliberate or unintentional, plagiarism violates ethical standards in scholarship" (p. 254). This same principle applies to the illicit use of AI.

Plagiarism: Researchers do not claim the words and ideas of another as their own; they give credit where credit is due. Quotations marks should be used to indicate the exact words of another. Each time you paraphrase another author (i.e., summarize a passage or rearrange the order of a sentence and change some of the words), you need to credit the source in the text. The key element of this principle is that authors do not present the work of another as if it were their own words. This can extend to ideas as well as written words. If authors model a study after one done by someone else, the originating author should be given credit. If the rationale for a study was suggested in the discussion section of someone else's article, the person should be given credit. Given the free exchange of ideas, which is very important for the health of intellectual discourse, authors may not know where an idea for a study originated. If authors do know, however, they should acknowledge the source; this includes personal communications (p. 11). For guidance on proper documentation, consult the Academic Success Center or a recommended guide to documentation and research such as the Manual of the APA or the MLA Handbook for Writers of Research Papers. If you still have doubts concerning proper documentation, seek advice from your instructor prior to submitting a final draft.

TAMUI has penalties for plagiarism and cheating.

- **Penalties for Plagiarism:** Should a faculty member discover that a student has committed plagiarism, the student should receive a grade of 'F' in that course and the matter will be referred to the Honor Council for possible disciplinary action. The faculty member, however, may elect to



give freshmen and sophomore students a “zero” for the assignment and to allow them to revise the assignment up to a grade of “F” (50%) if they believe that the student plagiarized out of ignorance or carelessness and not out of an attempt to deceive in order to earn an unmerited grade; the instructor must still report the offense to the Honor Council. This option should not be available to juniors, seniors, or graduate students, who cannot reasonably claim ignorance of documentation rules as an excuse. For repeat offenders in undergraduate courses or for an offender in any graduate course, the penalty for plagiarism is likely to include suspension or expulsion from the university.

- **Caution:** Be very careful what you upload to Turnitin or send to your professor for evaluation. Whatever you upload for evaluation will be considered your final, approved draft. If it is plagiarized, you will be held responsible. The excuse that “it was only a draft” will not be accepted.
- **Caution:** Also, do not share your electronic files with others. If you do, you are responsible for the possible consequences. If another student takes your file of a paper and changes the name to his or her name and submits it and you also submit the paper, we will hold both of you responsible for plagiarism. It is impossible for us to know with certainty who wrote the paper and who stole it. And, of course, we cannot know if there was collusion between you and the other student in the matter.
- **Penalties for Cheating:** Should a faculty member discover a student cheating on an exam or quiz or other class project, the student should receive a “zero” for the assignment and not be allowed to make the assignment up. The incident should be reported to the chair of the department and to the Honor Council. If the cheating is extensive, however, or if the assignment constitutes a major grade for the course (e.g., a final exam), or if the student has cheated in the past, the student should receive an “F” in the course, and the matter should be referred to the Honor Council. Additional penalties, including suspension or expulsion from the university may be imposed. Under no circumstances should a student who deserves an “F” in the course be allowed to withdraw from the course with a “W.”
- **Caution:** Chat groups that start off as “study groups” can easily devolve into “cheating groups.” Be very careful not to join or remain any chat group if it begins to discuss specific information about exams or assignments that are meant to require individual work. If you are a member of such a group and it begins to cheat, you will be held responsible along with all the other members of the group. The TAMIU Honor Code requires that you report any such instances of cheating.
- **Student Right of Appeal:** Faculty will notify students immediately via the student’s TAMIU e-mail account that they have submitted plagiarized work. Students have the right to appeal a faculty member’s charge of academic dishonesty by notifying the TAMIU Honor Council of their intent to appeal as long as the notification of appeal comes within 10 business days of the faculty member’s e-mail message to the student and/or the Office of Student Conduct and Community Engagement. The Student Handbook provides more details.

Use of Work in Two or More Courses

You may not submit work completed in one course for a grade in a second course unless you receive explicit permission to do so by the instructor of the second course. In general, you should get credit for a work product only once.

AI Policies

Your instructor will provide you with their personal policy on the use of AI in the classroom setting and associated coursework.

TAMIU E-Mail and SafeZone

Personal Announcements sent to students through TAMIU E-mail (tamiu.edu or dusty email) are the official means of communicating course and university business with students and faculty –not the U.S. Mail and no other e-mail addresses. Students and faculty must check their TAMIU e-mail accounts regularly, if not daily. Not having seen an important TAMIU e-mail or message from a faculty member, chair, or dean is not accepted as an excuse for failure to take important action.

Students, faculty, and staff are encouraged to download the SafeZone app, which is a free mobile app for all University faculty, staff, and students. SafeZone allows you to: report safety concerns (24/7), get connected with mental health professionals, activate location sharing with authorities, and anonymously report incidents. Copyright Restrictions

The Copyright Act of 1976 grants to copyright owners the exclusive right to reproduce their works and distribute copies of their work. Works that receive copyright protection include published works such as a textbook. Copying a textbook without permission from the owner of the copyright may constitute copyright infringement. Civil and criminal penalties may be assessed for copyright infringement. Civil penalties include damages up to \$100,000; criminal penalties include a fine up to \$250,000 and imprisonment. Copyright laws do not allow students and professors to make photocopies of copyrighted materials, but you may copy a limited portion of a work, such as article from a journal or a chapter from a book for your own personal academic use or, in the case of a professor, for personal, limited classroom use. In general, the extent of your copying should not suggest that the purpose or the effect of your copying is to avoid paying for the materials. And, of course, you may not sell these copies for a profit. Thus, students who copy textbooks to avoid buying them or professors who provide photocopies of textbooks to enable students to save money are violating the law.

Incompletes

Students who are unable to complete a course should withdraw from the course before the final date for withdrawal and receive a "W." To qualify for an "incomplete" and thus have the opportunity to complete the course at a later date, a student must meet the following criteria:

1. The student must have completed 90% of the course work assigned before the final date for withdrawing from a course with a "W", and the student must be passing the course;
2. The student cannot complete the course because an accident, an illness, or a traumatic personal or family event occurred after the final date for withdrawal from a course;
3. The student must sign an "Incomplete Grade Contract" and secure signatures of approval from the professor and the college dean.
4. The student must agree to complete the missing course work before the end of the next long semester; failure to meet this deadline will cause the "I" to automatically be converted to an "F"; extensions to this deadline may be granted by the dean of the college. This is the general policy regarding the circumstances under which an "incomplete" may be granted, but under exceptional circumstances, a student may receive an incomplete who does not meet all of the criteria above if the faculty member, department chair, and dean recommend it.



WIN Contracts

The Department of Biology and Chemistry does not permit WIN contracts. For other departments within the college, WIN Contracts are offered only under exceptional circumstances and are limited to graduating seniors. Only courses offered by full-time TAMIU faculty or TAMIU instructors are eligible to be contracted for the WIN requirement. However, a WIN contract for a course taught by an adjunct may be approved, with special permission from the department chair and dean. Students must seek approval before beginning any work for the WIN Contract. No student will contract more than one course per semester. Summer WIN Contracts must continue through both summer sessions.

Student Responsibility for Dropping a Course

It is the responsibility of the student to drop the course before the final date for withdrawal from a course. Faculty members, in fact, may not drop a student from a course without getting the approval of their department chair and dean.

Independent Study Course

Independent Study (IS) courses are offered only under exceptional circumstances. Required courses intended to build academic skills may not be taken as IS (e.g., clinical supervision and internships). No student will take more than one IS course per semester. Moreover, IS courses are limited to seniors and graduate students. Summer IS course must continue through both summer sessions.

Grade Changes & Appeals

Faculty are authorized to change final grades only when they have committed a computational error or an error in recording a grade, and they must receive the approval of their department chairs and the dean to change the grade. As part of that approval, they must attach a detailed explanation of the reason for the mistake. Only in rare cases would another reason be entertained as legitimate for a grade change. A student who is unhappy with his or her grade on an assignment must discuss the situation with the faculty member teaching the course. If students believe that they have been graded unfairly, they have the right to appeal the grade using a grade appeal process in the Student Handbook and in the Faculty Handbook.

Final Examination

All courses in all colleges must include a comprehensive exam or performance and be given on the date and time specified by the Academic Calendar and the Final Exam schedule published by the Registrar's Office. In the College of Arts & Sciences all final exams must contain a written component. The written component should comprise at least 20% of the final exam grade. Exceptions to this policy must receive the approval of the department chair and the dean at the beginning of the semester.

Mental Health and Well-Being
